He will be eligible for Health Benefits and Retirement available to other Certificated staff.

Mr. Clinton began his teaching career at Hansen School, inspiring young minds in the fourth/fifth grade combination class. He later brought his energy and dedication to Cerritos School, teaching a third/fourth grade combination class, before moving to Holder School in 2013 to teach fifth and sixth grades. Most recently, in 2022, Mr. Clinton joined Reid School, where he has supported students in Title I classes for the past three years.

Throughout his time in the Savanna School District, Mr. Clinton has provided leadership and a commitment to student success. He has served as a grade level team lead, a volunteer at the annual Reach the Reader night, and a member of the School Site Council, District Advisory Committee, Student Study Team, and site leadership teams. He has also played a vital role in organizing Field Days at Holder and Reid Schools, actively contributed to the PBIS teams, and was instrumental in creating organized lunch recess games – giving students opportunities to build friendships and stay active through flag football, nation ball, soccer, and basketball. In addition, Mr. Clinton has led our Summer Academy as principal for the past three years, showcasing his passion for creating meaningful learning experiences.

As we look toward the upcoming school year, the Board wholeheartedly supports the transition of principals across our schools, viewing these moves as exciting opportunities for our leaders to share their talents, inspire new school communities, and bring fresh ideas that will enrich every campus. These changes reflect our shared commitment to ensuring all Savanna students continue
